AFGE Local 1395 is accepting nominations for the 2025 Election of officers and delegates. You are receiving this letter as a member of AFGE Local 1395. Honest Ballot, an independent election services company, will oversee the nominations and election proceedings. The election will be held by mail ballot. More information and the ballot will be included in the voter information letter which you will receive prior to the election.

To be qualified as an officer or candidate for office, an individual must meet the following qualifications: (1) be a member in good standing in this local; (2) be a member for one year of an AFGE local; and (3) not be a member of any labor organization not affiliated with the AFL-CIO. Candidates shall not run for more than one office in the same local election. The term of office is three years ending with the installation of a successor.

To be a candidate, members must be nominated/self-nominated either at a designated membership meeting or by email or fax. If you would like to nominate someone for an office, please review the following information. Nominations will be accepted either (i) at the designated membership meeting which will be conducted virtually, by Zoom, on February 12, 2025, or (ii) by completing the enclosed Nominations Form and submitting it by email or fax by 5:00 P.M. (CST) on February 10, 2025.

- The member making the nomination has the responsibility to inform the nominee of his or her nomination.
- Candidates have the responsibility to submit a copy of the enclosed Acceptance Statement.
- Candidates may accept a nomination for ONE officer position. If accepting a nomination for a delegate position and an officer position, separate Acceptance Statements must be submitted.

Honest Ballot, on behalf of the Local, will include candidates' campaign literature with the ballot mailing provided the campaign literature is submitted by the candidate(s) to a member of the Elections Committee no later than February 28, 2025.

Campaign literature is limited to one 8.5" x 11" page, may be one or two sided and may be color or black & white.

NOTE: Every candidate who requests distribution of campaign literature shall pay to the Financial Secretary the expense of the printing and mailing.
