

CERTIFICATION BY HONEST BALLOT

Pursuant to a request of the AFGE, LOCAL 1395, Honest Ballot assigned personnel to supervise the election of Executive Officers and Delegates. The election was open from January 23, 2025 to April 29, 2025. Tabulation of the election results took place on May 5, 2025 via Zoom, at Honest Ballot, 27246 Grand Central Parkway, Floral Park, New York.

HONEST BALLOT HEREBY CERTIFIES that the election was conducted fairly, honestly and in accordance with the election guidelines of AFGE Local 1395.

HONEST BALLOT HEREBY CERTIFIES *one thousand two hundred & sixty-one (1,261)* Nominations Notices and Acceptance forms were mailed to members on January 23, 2025. Nominations (by mail) closed on February 10, 2025 at 5:00 P.M. Nominations (in person) were accepted at the regular membership meeting conducted on February 12, 2025. Acceptance forms were accepted through February 20, 2025. Candidate eligibility was confirmed by the AFGE 1395 Election Committee. *One thousand two hundred & sixty-one (1,261)* official ballots were mailed to members on March 12, 2025. The Affidavit of Mailing is attached hereto and considered part of said certification.


HONEST BALLOT FURTHER CERTIFIES *one hundred & one (101)* ballot envelopes were received for the General Election of Executive Officers. Of the *one hundred & one* envelopes received, *fifteen (15)* were voided because the ballots were submitted without a secret ballot envelope; thus, *eighty-six (86)* ballots were counted for the final tabulation.
