The American Federation of Government Employees Local 1395 (AFGE 1395) is conducting the 2025 triennial election of officers and delegates. The deadline for voting is **April 29, 2025**. Honest Ballot LLC, an independent, third-party election services provider, will oversee the election procedures and provide impartiality throughout the election and maintain anonymity of the votes. Voting will be by mail-in ballots only. For the health and safety of all involved, no in person will be available this year. Your ballot, secret ballot envelope, and a prepaid return envelope are enclosed with this letter.

All active members were notified of the call for nominations in a letter dated January 19, 2025. Nominations were open until February 12, 2025, and acceptances were closed as of February 27, 2025. Candidates for each office are listed on the ballot. Several of the offices received only one nomination. The list of unopposed candidates who are declared the office by acclamation are shown on the back of this letter.

Only members in good standing shall be allowed to vote. Officers, council delegates, and district caucus delegates shall be elected by a majority of the votes cast in a secret ballot by members in good standing. This letter is dated March 11, 2025 and serves as satisfactory notice of the election.

Voting instructions to submit your ballot by mail are detailed on the enclosed ballot. Failure to follow the instructions will void your ballot. Do not bring your ballot to the Union Office or give it to anyone. You must send your ballot by mail to Honest Ballot LLC.

Mail your ballot in time for it to be received by Honest Ballot by 12:00 Noon on **April 29, 2025**.
